General Membership Meeting Summer 2009
May 6, 2009
Crossflights
Susan Hollingsworth called the meeting to order at 7:30pm. She thanked Crossflights for allowing our meeting.

Susan Hollingsworth called for the secretary's report. Marci Medley read the minutes. A motion was made by Susan Davis to correct the treasurer's report from the January 2009 membership meeting. The ending balance for December 31, 2009 should have been $\$ 3,356.82$. The motion was seconded and passed.

Susan Hollingsworth called for the treasurer's report. Susan Davis stated that the laptop and QuickBooks program have been purchased and work is being done to set up the QuickBooks program. An Audit committee has been formed and met on Saturday. A CPA will review the books yearly and also do the CVDA's tax return. Records from 2007 and 2008 were sent to the CPA, after review the total amount of $\$ 8,856$ was found to be fraudulently removed from the CVDA accounts. We have received that money back from the former treasurer. Susan Davis then read the financial report.

A motion was made to accept the reading of the financial statement. The motion was seconded and passed.

Thanked the area representatives for all of their help during the season. He stated that the score sheets looked pretty good; please check your sheet with the other captain at the end of the night. He stated that there are some new teams this season with new players. If you are playing against them please help them with their score sheets.

Susan Hollingsworth called for the Vice President's report. Ken Davis thanked everyone for the opportunity to be the Vice President. He stated he was interested in being involved and learning while serving on the CVDA board. He announced: the May Malee May 16 and $17^{\text {th }}$ at Livewires. The CVDA Dart Classic June 12-14 at the Koger Center. He stated that the success of these events depends on members support.
